



MOHR 2019 Award Program

The Minnesota Organizations for Habilitation and Rehabilitation (MOHR) is accepting nominations for our 2019 Awards, honoring **Direct Support Professionals**. The award winners will be recognized at our MOHR Annual Meeting and Conference on Thursday, May 16th, in St. Cloud, MN. **Nominations will be accepted through March 29th, 2019.**

The Awards will be honoring **Direct Support Professionals** in the following 4 categories:

- Employment Service – “Job Coach” – Greater Minnesota (outside of the 7 County Metro Area) – Include employees working with Extended Employment and CRP individuals.
- Employment Service – “Job Coach” – 7 County Metro Area - Include employees working with Extended Employment and CRP individuals.
- Enrichment Focus – (working with individuals who choose community enrichment supports) - Greater Minnesota (outside of the 7 County Metro Area)
- Enrichment Focus – (working with individuals who choose community enrichment supports)- 7 County Metro Area

The MOHR DSP Awards honor individuals employed with a MOHR member agency to provide direct service for people with disabilities. The nominees should demonstrate exemplary skills, characteristics and traits that have impacted the lives of people with disabilities, as well as the creation and implementation of innovative and proactive services.

- **Please submit your nomination on the attached form; one nominee per form.**
- Include the award category; attach any supporting materials that you may feel relevant. For example, documentation of what the person has done. Supporting materials may include, but not limited to, newspaper clippings, letters of support from those who know the nominee well and photos.
- Nominees need to be from MOHR Member agencies and work direct service 75% or more of their job responsibilities
- All DSP nominees will be recognized with a Certificate of Recognition.
- Award winners are selected by the designated selection committee.
